Singhania University: a statutory body established by the Act of State Legislature viz. Singhania University Pacheri Bari (Jhunjhunu) Act, 2008 (recognized as per Section 2(f) of UGC Act, 1956) having its main campus at Pacheri Bari, Jhunjhunu (Rajasthan) represented through Mrs. AKSHAMA GUPTA (hereinafter referred to as "Second Party" which expression shall mean to include its successors and permitted assignees)

The First Party and the Second Party shall individually be referred to as "Party" and shall be collectively referred to as the "Parties".


